ALL OUR ARTICLES, ALWAYS, IN ONE WAY OR ANOTHER, CAN BE DESTINED FOR A SECOND LIFE. ON EACH ARTICLE THE RELEVANT RECYCLING CODE IS PRINTED. THIS IS AN INTERNATIONAL CODE TO ALLOW TO RECOGNIZE IN A CLEAR AND IMMEDIATE WAY THE TYPE OF MATERIAL OF WHICH THE RECYCLABLE OBJECT IS MADE.

EUROPEAN LEGISLATION PROVIDES FOR THE RECYCLING OBLIGATION ONLY FOR PRODUCTS IN PLASTIC REPRESENTING PACKAGING. IN THE CONTRIBUTION IS ALREADY INCLUDED, IN FACT, A COST TO BE PAID BY PRODUCERS TO THE CONSORTIUM DEALING WITH THE MANAGEMENT OF RECOVERY AND RECYCLING OPERATIONS (CONAI FOR ITALY).



FOR ANYTHING THAT DOES NOT CONSTITUTE PACKAGING, OUR COMPANY ADHERES TO THE POLIECO CONSORTIUM, WHICH AIMS TO ENCOURAGE THE WITHDRAWAL OF POLYETHYLENE-BASED GOODS AT THE END OF THEIR LIFE CYCLE, IN ORDER TO START THEM UP TO RECYCLING AND RECOVERY ACTIVITIES, AT THE SAME TIME A REDUCTION IN THE AMOUNT OF WASTE DISPOSED OF IN LANDFILLS AND A LOWER CONSUMPTION OF RAW MATERIALS (WITH ALL THAT THAT RESULTS IN TERMS OF ENERGY SAVINGS AND LOWER EMISSIONS FROM LACK OF INDUSTRIAL PRODUCTION).

DESPITE ALL THE CARE AND ATTENTION ALREADY RESERVED FOR OURS ECOSYSTEM, WE HAVE STUDIED A FURTHER LINE IN AN EVEN MORE PERSPECTIVE ECOSUSTAINABLE: THE ECOCARE LINE HAS BEEN REALIZED WITH ALL THE ATTENTION DEDICATED TO THE ENVIRONMENT AND THE RAW MATERIAL, SO THAT THE FINAL CONSUMER CAN USE OUR PRODUCTS ENSURING AN EVEN LOWER ENVIRONMENTAL IMPACT.

CERTIFICATIONS

THE COMMITMENT WE PUT INTO COMPANY MANAGEMENT AND IN OUR PRODUCTS IS DOCUMENTED AND CERTIFIED BY AUTONOMOUS CONTROL BODIES. WE THINK THAT THESE VOLUNTARY REGULATORY FRAMEWORKS, WHICH INVOLVE OUR MANAGEMENT SYSTEM AND OUR PRODUCTS, ARE FUNDAMENTAL IMPORTANCE TO ENSURE RELIABILITY AND TRANSPARENCY THAT ALWAYS IS RECOGNIZED.

ENGAGING IN THE ENVIRONMENTAL FIELD IN GAMMAPLAST MEANS TO GUARANTEE THE BIODEGRADABILITY OF THE PRODUCTS THAT ARE SOLD, PARTICIPATING IN CHECKS ON THE COMPOSITION OF RAW MATERIALS. IN A WORD: COMPOSTABILITY CERTIFICATION ACCORDING TO UNI EN 13432: 2002, LICENSE CODE S481.



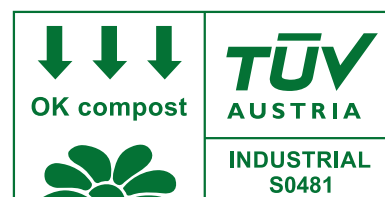
THE FSC CERTIFICATION IS AN INTERNATIONAL CERTIFICATION, INDEPENDENT AND THIRD PARTY, SPECIFIC FOR THE FOREST SECTOR AND THE PRODUCTS, WOODY AND NON-WOOD, DERIVED FROM FORESTS AND ENSURES THAT THE PRODUCTS COME FROM RESPONSIBLY MANAGED FORESTS, ENSURING ENVIRONMENTAL, SOCIAL AND ECONOMIC ADVANTAGES. FSC FOREST MANAGEMENT STANDARDS INCLUDE THE PROTECTION OF WATER QUALITY, PROHIBIT THE CUTTING OF ANCIENT FORESTS, PREVENT THE LOSS OF NATURAL FOREST COVER AND PROHIBIT THE USE OF HIGHLY TOXIC CHEMICALS - ALL ASPECTS THAT AFFECT THE MANAGEMENT SYSTEM OF A FOREST.
